

Colorado Coroners Standards and Training Board (CCSTB) July 16, 2020 MEETING MINUTES

Call to order

Randy Keller, Chair, called the July 16, 2020, Colorado Coroners Standards and Training Board (CCSTB) meeting to order at 9:30 a.m. This meeting was remote only via web and phone conference.

Roll call

A quorum was established.

April minutes: ACTION ITEM One edit was made to change October to January minutes. Commissioner Engels motioned to approve the April minutes, seconded by Dr. Kelly. The minutes were approved unanimously.

Membership: No updates

Officers: ACTION ITEM: Nominations were opened for the Compliance Review Officer. Dr. Kelly nominated Mr. Graf, seconded by Commissioner Engels, and the nomination was accepted. No other nominations were made and the vote was unanimous to appoint Mr. Graf as the Compliance Review Officer.

Colorado Coroners Association training updates: Mr. Keller stated he will be attending a meeting with CCA and the end of July to discuss moving the training to early October in Colorado Springs. With trainings being cancelled or postponed, the board will need to discuss how to address compliance for 2020 education with limited training opportunities. Potential solutions may include approving online education credits, deadline extensions or other solutions that members may propose.

Legislative updates: Mr. Keller provided information on HB20-1397 which removes CDPHE administrative support of certain boards, which includes CCSTB. The board still has remaining funds of about \$53,000. The remaining and future funds will continue to go to CDPHE and CDPHE can reimburse a contractor expenses related to the board's function, including administrative support. CDPHE staff will reach out to have a financial report for the board at the October meeting. Members discussed the Colorado Coroners Association (CCA) as a vehicle to provide administrative support. This was with caution to ensure that the CCA will continue to provide Coroners with documents as requested and coroners must submit documents to the CCSTB for compliance review.

ACTION ITEM: Commissioner Thomas moved to support transitioning administrative duties to the CCA, seconded by Dr. Kelly. Mr. Keller abstained due to a conflict of interest with his leadership role with CCA. Mr. Graf also offered to abstain due to his membership on the CCA board. The CCSTB members chose to include Mr. Graf's vote in order to meet the necessary votes based on quorum. The vote was approved unanimously.

ACTION ITEM: Commissioner Engels motioned to approve Mr. Vigil's MLDI submission, seconded by Dr. Kelly. The motion passed unanimously.

Mr. Larson's MLDI was submitted but is expired. Mr. Hankins had requested an extension and sent proof of his MLDI application submission. Mr. Boren had an extension request approved and thought his certificate was already submitted after his application to CCA was sent in. Information from CCA is that all three coroners will be compliant after submitted documentation is processed. ACTION ITEM: Mr. Graff motioned to send correspondence to Mr. Larson, Mr. Hankins, and Mr. Boren to submit the current MLDI certificate to the CCSTB, seconded by Ms. Cannon. The motion and it was approved unanimously.

• Shannon Kent, Lake county has already had letters mailed and emailed to him and the county commissioners to withhold pay due to noncompliance with multiple requirements. Further action by the board is not necessary at this time.
